Every year more than 10 million people die unnecessarily from consuming tobacco, alcohol, and sugary beverages. Evidence demonstrates that health taxes are one of the most effective ways to reduce the consumption of unhealthy products, ideally as part of a strategic public health approach. - Emphasis on lived experience as a driver of more inclusive, effective policies and services.
